## RULES AND REGULATIONS

Exhibitors are required to use the Application form and abide by the Rules and Regulations of the EXHIBITION as specified below:

- 1. The Exhibitor should apply on Application Form for Participation with requisite payment. Allotment will be on 'first-come-first served' basis.
- **2.**The ORGANIZER reserves the right to reallocate space, change the layout, add or delete corridors in space plans which may affect the orientation of some EXHIBITORS. The decision of the organizer shall be final and binding. All the payments are to be cleared by 15<sup>th</sup> June 2017. The booking of the stall/s is liable to be cancelled if full payment is not received by the above date. The Exhibitors shall not organize concurrent show during PLASTASIA-2017 Exhibition.
- 3. The organisers will do their level best to ensure proper supply by the Authorized Contractors.
- **4.** The EXHIBITOR enters into a contract with the Organiser on submission of the Application Form. The Company (Proposed Exhibitor) agrees to participate at the Exhibition PLASTASIA 2017 and abide by the regulations and by-laws of the Exhibition. Upon any breach of contract by the Proposed Exhibitor, the Exhibitor is liable to pay the Participation Expenses in full to the Organizer.
